Personal Data



Personal Data means any data relating to an identifiable natural person (known as the data subject) such as name, address, telephone number, email address, race, origin, medical and health information, etc.

Why We Hold Personal Data

We collect Personal Data: -

- a) To comply with legislative and regulatory requirements
- b) To provide services and products to our clients
- c) To enable us to obtain services and products from our suppliers
- d) To enable us to fulfil our obligations under a contract with yourself
- e) Where you give us your consent to hold and use your personal data

We also collect information to better understand our business.

How Do We Collect Personal Data
